Cork County Council Anti-Litter Challenge 2018

The Anti-Litter Challenge raises awareness of litter pollution and motivates communities to reduce litter by introducing an element of friendly competition. This year the competition will run from 14th May to 20th June. For villages in the county final there will be additional judging from 9th to 13th July.

Judging Periods

First Period: 14th May – 23rd May

Second Period: 28th May – 6th June

Third Period: 11th June – 20th June

Villages County Final: 9th July – 13th July

Judging

All Towns and villages will be judged under as similar circumstances as possible. This means that:

- Judges will try to avoid visits on any day on which there is a special event, e.g. mart day or casual trading day. The council should be notified in advance of these events.
- Judging will take place between 9am and 5pm, Monday to Friday.
- Judging will not take place on Saturdays, Sundays or Bank Holidays.
- All public areas between the 50km speed limit signs can be judged.
- Marks are deducted for litter only, as defined in the Litter Pollution Act, 1997.
- Marks will not be deducted for abandoned cars, illegal signs, unfinished housing estates, kerbside weeds, derelict buildings.
- No marks will be awarded for well-kept open spaces, or well presented buildings. Only litter is judged.
- An extra period of judging, or some other mechanism, may be used to separate towns or villages in a tie-break situation.
- Judges decisions are final.

Marking Scheme - Villages

- Villages start each judging period with 100 points maximum points available: 300
- Points from each judging period will be added together to give the final total
- 1 point is deducted for each piece of litter

- 0.1 point is deducted for each cigarette butt, i.e. 10 cigarette butts = 1 point deducted
- Judges will walk through the streets and drive through the housing estates
- Maximum 2 Housing estates will be judged per visit
- Streets will constitute 90% of the points, housing estates 10%, i.e. 5% for each estate
- If a village has only 1 housing estate then that estate will constitute 10% of the points
- If a village has no housing estates then streets will constitute 100% of the points

Marking Scheme - Towns

- Towns start each judging period with 1,000 points maximum points available: 3,000
- Points from each judging period will be added together to give the final total
- 1 point is deducted for each piece of litter
- 0.1 point is deducted for each cigarette butt, i.e. 10 cigarette butts = 1 point deducted
- 10 x 50 metre stretches of road/footpath will be judged in each town as follows:
 - o 10 x 50 metre stretches in the town centre
 - o 2 x 50 metre stretches in a housing estate/residential area
 - o 1 x 50 metre stretch in a service area/school area
 - o 1 x 50 metre stretch adjacent to a green area
- Towns may nominate 1 estate for judging in each period if they wish

Competition Structure - Villages

- Villages will compete in one of three divisions: North, South, or West
- Each division will have two groups, A and B
- Prizes will be awarded to 1st, 2nd & 3rd places in each group amounts to be confirmed
- Prizes will be awarded to the best improver in each group
- The winners of group A from each division will progress to the County Final
- Non-prize winners with a final score of 210 points or higher will receive a participation grant of €150
- Villages placing 1st, 2nd or 3rd, and best improvers are not eligible for the participation prize
- 1st place from group A in each division will progress to the county final
- 1st & 2nd place in Group B will be promoted to Group A
- The bottom 2 in Group A will be relegated to Group B

Competition Structure - Towns

- Towns will compete in one of three categories: A, B1, or B2
- Prizes will be awarded to 1st, 2nd & 3rd places in each category amounts to be confirmed
- There will be one best improver prize
- Non-prize winners with a final score of 2,100 or higher will receive a participation grant of
 €300
- 1st & 2nd place in Category B1 will be promoted to Category A
- 1st & 2nd place in Category B2 will be promoted to Category B1
- The bottom 2 in Category A will be relegated to Category B1
- The bottom 2 in Category B1 will be relegated to Category B2
